# Fundraising Raffle for Australasian Dance Collective Terms & Conditions

# 1. Promoter Information

The promoter of the raffle is Australasian Dance Company (ADC), a registered charity under Australian law, ABN 12 010 545 187, located at 3/420 Brunswick Street, Fortitude Valley QLD 4006.

ADC will conduct a fundraising raffle in accordance with the *Charitable and Non-Profit Gaming Act 1999* under the regulations of Category 2 games.

# 2. Eligibility

Participation in the raffle is open to all individuals other than ADC staff directly associated with the administration of the raffle and their immediate families who live at the same premises.

# 3. Raffle Period

The raffle begins on 31 October 2024 and closes on 8 November 2024. All tickets must be purchased before the close of the raffle period. Late entries will not be accepted.

#### 4. Ticket Information

Each raffle ticket costs a maximum of \$50.00 AUD with group bundles available for purchase and ticket sales will not exceed \$31,500 AUD gross proceeds.

# 5. Prize Details

The prizes are listed on the website <u>here</u> and will be drawn in the order of least to most value.

Please note some values listed alongside the prizes are estimates only. Prizes cannot be substituted and are not redeemable for cash.

# 6. Draw Date and Method

The raffle draw will take place on Monday 11 November at 1:00pm AEST at Australasian Dance Collective in Brisbane. Winners will be selected at random through a manual draw, ensuring fairness and transparency. The results of the draw are final and binding.

# 7. Notification of Winners

Winners will be notified via email within 48 hours of the draw. All reasonable attempts will be made to contact the winner via email and telephone.

# 8. Prize Collection

All prizes must be collected in person from Australasian Dance Collective Office (Brisbane), or other collection arrangements may be made at the discretion of ADC. Winners are responsible for any additional costs associated with collecting or transporting the prizes.

Prizes must be collected within **one month** of the winners being decided. The above does not apply if:

- the prize winner agrees in writing that the prize may be delivered more than one month after the winners are decided or
- after making all reasonable efforts, the eligible association conducting the art union cannot locate the winner of the prize.

# 9. Unclaimed Prizes

ADC must keep unclaimed prizes for one year of the Draw Date. ADC reserves the right apply the prize or its sale proceeds to the associations' purposes. If the prize is not claimed within one year the eligible association may apply the prize or its sale proceeds to the association's purpose.

# 10. Refund Policy

Once purchased, raffle tickets are non-refundable except in the case of cancellation of the raffle by ADC. In the event of cancellation, all ticket holders will be notified, and a refund will be issued.

# 11. Liability

ADC will not be responsible for any loss, damage, or personal injury sustained by the winners in connection with the prizes or participation in this raffle.

# 12. Privacy Policy

ADC respects the privacy of all entrants. Any personal information collected will be used solely for the purposes of conducting the raffle and will not be shared with third parties without consent.

# 13. Disqualification

ADC reserves the right to disqualify any entries that it believes, in its sole discretion, do not comply with these terms and conditions or where the participant is found to have tampered with the entry process.

# 14. Amendments

ADC reserves the right to amend or update these terms and conditions at any time without notice.
